# TALKING POINTS AUGUST 2020

#### **LEGISLATIVE**

- The annual Arizona REALTOR® Party Training and REALTOR® Caucus will now be hosted through the Zoom virtual platform.
  - The Arizona REALTOR® Caucus is the kickoff of the "new year" for the Arizona REALTORS® to assess Arizona public policy, gather valuable input from members, and identify current issues affecting the real estate industry.
  - Through the caucus process, on behalf of our members, the Arizona REALTORS®
    can best recommend possible legislative or regulatory actions for the upcoming
    legislative session.
  - Wednesday, September 2<sup>nd</sup> REALTOR® Party Training
  - Thursday, September 3<sup>rd</sup> REALTOR® Caucus
- The Association released 2020 legislative endorsements for the Arizona Senate and Arizona House of Representatives which can be found at: <a href="https://www.aaronline.com/2020/06/22/2020-primary-election-endorsements/">https://www.aaronline.com/2020/06/22/2020-primary-election-endorsements/</a>. The Association endorsed 29 Senate and 47 House candidates. The Arizona REALTORS® are confident that each of these candidates understands the issues of concern to the real estate community, homebuyers, sellers, and property owners in Arizona.

These endorsements are for individuals who actively support the REALTOR® Party. The only "affiliation" that is considered is whether they support REALTOR® issues.

#### The endorsement process:

- 1. Candidates that have filed to run for a statewide or legislative district, are sent the Arizona REALTORS® candidate questionnaire. Incumbents are not required to complete the questionnaire; their voting record for the previous two years will be used to determine if they are REALTOR® friendly.
- **2.** Once the candidate questionnaires are returned, the Government Affairs Director analyzes the answers of the candidates in comparison to the information gained by the vote analysis and makes recommendations to the RAPAC Trustees.
- **3.** The RAPAC Trustees review the recommendations and decide whether to: endorse the candidate, endorse the candidate with money, or to not endorse the candidate.
- The Arizona REALTORS® were once again successful in proactively passing legislation to expand the use of electronic signatures while defeating numerous bills.
- POLICY RELATED TO COVID-19 In late July the REALTORS®, in partnership with other industry stakeholders, submitted a letter to Governor Ducey opposing any extension of the Postponed Evictions Executive Order. In the letter, the REALTORS® argued that the Governor should reevaluate the rental assistance program and reduce barriers to

assistance. The letter, on behalf of private rental property owners and managers, urged the Governor to utilize the unprecedented resources under his discretion to help those in need, and that the state's efforts need to be focused on improving the deployment of those tools like:

- Reducing the qualifications for the Rental Assistance Program (cut the red tape) to improve the current 6% approval rate.
- Eliminating the requirement that eligible households be responsible for paying 30% of their total gross month's income to their landlord.
- Allowing rental housing owners or managers to apply for assistance on behalf of residents who are delinquent or at risk of eviction.

Arizona REALTORS® did not make these suggestions without acknowledging the sensitivity and humanity property owners have shown to their tenants through this difficult time – offering discounts for timely payment, concessions, rent forgiveness, the waiver of late and other fees, and payment plans. Simply put – Arizona REALTORS® and the other members of this coalition are advocating for better government, once again.

This summer the Arizona REALTORS® had three advertorials in the Arizona Republic as part of the Rebuilding America promotion. The promotion was designed to help communities confidently navigate the economic and social "reopening" during the pandemic with a focus on what consumers can expect.

# COVID-19

The state association continues to make sure that members around the state have the information they need during the COVID-19 pandemic.

- Information: a webpage <a href="https://www.aaronline.com/covid-19/">https://www.aaronline.com/covid-19/</a> dedicated to compiling the most up-to-date information on the pandemic and how to continue conducting business while safeguarding your health and the health of your clients.
- Transactional documents: <u>COVID-19 Addendum</u> and a <u>Model certification for Property Access form</u> are available for member use.
  Additionally, a "How Arizona REALTORS are Taking Precautions to Protect Buyers/Sellers During Pandemic" <u>flyer</u> is available in a printable format. Both the Addendum and Flyer are translated into Spanish.
- Financial Assistance: Implemented a COVID-19 Relief Hotline for the month of May, which was staffed by our Legal Hotline Attorneys. The hotline, which was suspended on May 29<sup>th</sup>, answered 1,221 calls from REALTORS® asking financial assistance questions related to the pandemic. NAR's COVID-19 hotline is still available by calling 1-800-874-6500.
- Governmental: The Arizona REALTORS® were instrumental in the Governor classifying real estate as an "essential service" and moving up the effective date of the Remote Online Notarization statute to April 10<sup>th</sup>. Additionally, the Arizona REALTORS® have been a leading voice at the table as the state develops and enacts liability policies as they pertain to COVID-19.
