On August 28, 2020, an email vote was sent to the Executive Committee for the following motion:

MOTION: TO ALLOCATE \$2,000 FROM OPERATING RESERVES TO JOIN AN AMICUS CURIAE BRIEF ASKING THE ARIZONA SUPREME COURT TO ACCEPT SPECIAL ACTION JURISDICTION IN CV-20-0228-SA AND DECLARE THE EVICTION MORATORIUM (EXECUTIVE ORDER 2020-49) UNCONSTITUTIONAL.

On August 28, 2020, there was a unanimous vote to approve the motion.
