GVC Committee Reports

Canoa Hills Trails Park Survey Results

GVC Parks Advisory Standing Committee, Debbie Kenyon, Chair The GVC Foundation, Friends of Canoa Parks

At the general public meeting on the Draft Master Plan for the Canoa Hills Trails Park, the Pima County Flood District relayed the results of the responses (**n**=**5**84) to the survey as of February 19, 2021.

- · 89% of responses came from Green Valley residents.
- 62% live within 5 miles of the Trails.
- · 31% visit 3 or more times per week.
- 64% arrive by motor vehicle.
- · 79% engage in walking and running activities.
- · 30% hope to engage in picnicking and other social gathering events.
- · 60% predominantly use the park area east of Camino del Sol.
- · 20% use the western park area.
- · Restrooms are most desired amenity.
- Ecological restoration was the most important project goal.

The Planning & Architectural Committee has recently Reviewed and Proposed Changes to the Pima County Sign Codeand to help preserve Green Valley's southwestern style and dark skies. More recently the committee reviewed proposed plans for construction of the New Commerce Bank Building at 265 W Continental Road. At its last meeting in February, the committee members discussed the location of the Electronic Message Board at the Valley Presbyterian Church on Camino del Sol and the painting of the Canopy Poles for the Marathon Station located at 3000 Camino Del Sol (see the Planning &

Architectural Committee minutes posted on the GVC Website).
