Black History Month is celebrated annually to recognize the achievements and contributions made by African Americans throughout U.S. history.

In 1926, the Association for the Study of Negro Life and History (ASNLH), an organization founded by noted historian Carter G. Woodson and minister Jesse E. Moorland, sponsored the first "Negro History Week." In 1976 President Gerald Ford officially recognized February as Black History Month stating that the country needed to "seize the opportunity to honor the too-often neglected accomplishments of Black Americans in every area of endeavor throughout our history." **For more** on Black History Month, and the

#### **BLACK HISTORY AND REAL ESTATE**

#### **Supreme Court Decisions**

<u>Shelley v. Kraemer</u> (1948) – restrictive covenants in real property deeds prohibiting the sale of property to non-Caucasians violates the equal protection provision of the Fourteenth Amendment.

<u>Jones v. Mayer Co.</u> (1968) – Congress can use its enforcement power under the Thirteenth Amendment to prohibit private racial discrimination in the sale of property

#### Fair Housing Act

April 11, 1968: The Civil Right Act of 1968, also known as the Fair Housing Act — which "prohibits discrimination concerning the sale, rental, and financing of housing based on race, religion, or national origin," was signed by President Lyndon B. Johnson. Fair Housing for All Timeline

This annual report is created to examine the Black homeownership gap in America and suggest strategies to help close the gap.


