## **HOUSING REPORTS**

Arizona REALTORS® was the first state association to gain access to the REALTORS® Property Resource (RPR) to create an Arizona Housing Report of market activity. This was accomplished through cooperation with each Arizona MLS. The association's website includes an "Arizona Housing Report" button on the homepage so members can access the latest report. The reports will be updated monthly.

Additionally, NAR will use these reports for policy and advocacy activities before Congress. The up-to-date, targeted information will allow NAR staff, FPCs and Arizona REALTORS® staff to provide real-time examples of market activity, helping to enhance NAR and Arizona REALTORS® policy positions and priorities.

#### RAPAC FUNDRAISING GOALS -

- **2022 Fundraising Goal** is \$1,188,759. So far, we have raised over \$915,000, which is roughly 77% of goal.
- Our Major Investor goal is 313 and so far, we have 226 recognized major investors, and 10 installment plans of unrecognized major investors (69 additional installment plans of recognized MIs who have not fulfilled the entire pledge goal yet)
- Our Participation goal is 34 % and so far, we are at 29.90%.
- Our President's Circle goal is 31 and we are at 63 this year, handedly beating the 2021 total of 46 and doubling our 2022 goal

#### REALTOR® PARTY CORPORATE ALLY PROGRAM -

#### **2022 LEGISLATIVE SESSION –**

The 2022 Legislative Session has officially adjourned for the year on Saturday, June 25<sup>th</sup> after passing a historic bipartisan budget. Our advocacy team was hard at work all year fighting to support and protect the real estate industry. Some of our major legislative successes of the bills we supported that were signed into law are listed below.

- Arizona REALTORS® Bill HB2172: Codifying statutes to support real estate teams' ability to hire licensees as W-2 employees.
- **HB2747:** Requires disclosure of wholesale buyers and sellers of residential real estate.
- **HB2674:** Establishes the Housing Supply Study Committee with the Arizona REALTORS® represented on the Committee. The first meeting of introductions and outlining the scope was held in early July.
- **HB2101:** Protected Arizona from a deregulated utility market which ensures Arizona will have a reliable and affordable grid.
- **SB1168:** This bill related to the regulation of short-term rentals. While the Arizona REALTORS® was neutral on the bill, we were able to successfully prevent any amendments that would have opposed caps or limits on short-term rental inventory.

#### TOUR OF THE STATE CAPITOL -

**During the December 2021 NAR REALTOR Party Training the** Government Affairs tour of the state capitol video was recognized by NAR as one of the top 3 videos submitted! In the video, Government Affairs Director Matt Contorelli gives members a behind the scenes glimpse of where the laws affecting our industry are made. FORMS – Additional Clause Addendum On June 1<sup>st</sup>, a revised Additional Clause Addendum was released. The Additional Clause Addendum was revised to clarify that, in the event there is a conflict between the terms and conditions of the purchase contract and the Additional Clause Addendum, the terms included in the Additional Clause Addendum will prevail. This clarification helps ensure that the terms of the Additional Clause Addendum are never found to be in conflict with the terms of the Residential Resale Real Estate Purchase Contract.

The additional verbiage is added to lines 8-10 and states "In the event of a conflict between the terms and conditions of the Contract and this Additional Clause Addendum, the terms and conditions of this Additional Clause Addendum shall prevail."

## Seller's Property Disclosure Statement (SPDS)

A workgroup was formed to update the Seller's Property Disclosure Statement (SPDS). The workgroup has completed their revisions to the SPDS and the SPDS was submitted to the Loop for its review and comments. The workgroup is scheduled to meet in August to review the Loop comments and make any additional changes.

The Buyer's Inspection Notice and Seller's Response (BINSR) workgroup was recently reconvened as the Risk Management Committee granted the workgroup permission to revise Section 6j of the Residential Resale Real Estate Purchase Contract (Contract) so that the workgroup could complete its task of revising the BINSR. The revised BINSR and Contract was submitted to the Loop for its review and comments on July 15<sup>th</sup>.

#### PROFESSIONAL STANDARDS -

In 2021 we received **209** ethics complaints and **29** arbitration requests. In total, we held **71** hearings.

Through the second quarter of 2022, we received **104** ethics complaints and **13** arbitration requests. In total, we held **27** hearings.

#### AIR/CRE FORMS UPDATE -

The Arizona REALTORS® maintains an agreement with the AIR Commercial Real Estate Association which gives members the ability to purchase AIR commercial real estate forms at a discount. In September 2020, AIR released new commercial forms that have been "localized" for Arizona and reflect Arizona law. These revised forms have been well received by the Association's commercial practitioners.
