- 2. \$500,000 allocated to the Capital Reserve
- 3. \$800,000 allocated to the Strategic Initiative Fund
- 4. \$ 300,000 allocated to the Arizona Homeownership Alliance

Which leaves \$ 259,528 in unallocated status for cash flow purposes.
