# **HOUSING REPORTS**

Arizona REALTORS® was the first state association to gain access to the REALTORS® Property Resource (RPR) to create an Arizona Housing Report of market activity. This was accomplished through cooperation with each Arizona MLS. The association's website includes an "Arizona Housing Report" button on the homepage so members can access the latest report and archived reports. The reports will be updated monthly. The housing report lists Sales, Listings, Median Sales Price, inventory and much more! We have recently added a Housing Report archive to provide historical data. Coming soon, in addition to the statewide report, we plan to provide localized reports.

Additionally, NAR will use these reports for policy and advocacy activities before Congress. The up-to-date, targeted information will allow NAR staff, FPCs and Arizona REALTORS® staff to provide real-time examples of market activity, helping to enhance NAR and Arizona REALTORS® policy positions and priorities.

"RPAC's mission is to identify candidates for elected office on the local, state, and national levels who will work with REALTORS® to promote and protect the American Dream of property ownership. Candidates who receive support from RPAC <u>are not selected based</u> on their political party or ideology, but solely on their support of real estate issues."

SAAR and Phoenix REALTORS held successful dues billing raffles to increase fair share participation and encourage members to step up to a major investor level. Several local associations are planning first time fundraising events such as the NAAR auction, LHAR auction returning, PAAR MI event, WMAR MI event.

# **Housing Supply Study Committee -**

Arizona REALTORS® Government Affairs Director, Matt Contorelli, has been working hard as an appointed member of the Housing Supply Study Committee. Matt has been working with other elected and stakeholder appointees to further evaluate solutions to the housing crisis and ensure the REALTORS® remain influential as policy is crafted for the 2023 Legislative Session.

## 2023 LEGISLATIVE SESSION -

The 2023 Arizona Legislative Session began Monday, January 9<sup>th</sup>, where Governor Hobbs gave her first State of the State address, in which she outlined her legislative priorities. The Arizona REALTORS® have been working with Governor Hobbs, Senate President Warren Petersen, Speaker of the House Ben Toma, and all legislators this session as we work to advance and defend the 2023 Arizona REALTORS® Legislative Policies.

### **Legislative Priorities:**

- SUPPORT eliminating residential rental tax.
- SUPPORT responsible solutions to the housing crisis.
- SUPPORT substantive water conservation and management policies that will ensure Arizona's long-term water supply.
- OPPOSE efforts to deteriorate construction defect laws.
- OPPOSE efforts to cap or limit the number of short-term rentals while engaging solutions to challenges cities face due to the growing industry.
- Engage legislation on HOA regulation and accountability.
- Fight against unfunded mandates that could increase licensure fees.
- ADVOCATE for responsible water policy.
- ALWAYS protect private property rights and opportunities to widen the opportunities for housing and homeownership.

#### **FORMS RELEASE DATES –**

Previously the Arizona REALTORS® released forms on or about February 1st, June 1st, and October 1st. Starting in 2023, the forms release dates will be on or about February 1st, July 1st, and November 1st unless there is a change in law that necessitates an earlier release. The reason for this change is so that the release dates will coincide with the Risk Management and Executive Committee meeting dates for approval of new and revised forms.

#### FORMS -

# Seller's Property Disclosure Statement (SPDS)

The last major revision to the SPDS was in 2014. Accordingly, the SPDS has been revised and is scheduled for release on February 1, 2023.

Some of the more significant revisions include: (i) more information requested in the property and ownership section such as knowledge of rental regulations and whether the property is designated as a historic home or located in a historic district; (ii) a section for the seller to list the names and license numbers of all contractors and the scope of work that was performed on the Property in the past year; (iii) the Sewer/Wastewater Treatment section and Environmental Information section were relocated so that sewer information is disclosed before environmental information; and (iv) added Notices to Buyer and Seller regarding subdivided properties, when a contractor's license is required for work performed on the property, and updating the SPDS on a Notice/Disclosure form.

### **Fair Housing Advisory**

The Fair Housing Advisory is dedicated to educating consumers about fair housing practices. In mid-January, the Fair Housing Advisory was released to brokers and is available to all members in the forms' platforms beginning February 1, 2023. The advisory is not copyrighted, and members are encouraged to brand the form.

Additionally, workgroups have been formed to revise the Multiple Counter Offer, Buyer Contingency Addendum, and Additional Clause Addendum.

#### PROFESSIONAL STANDARDS -

In 2022, we received **192** ethics complaints and **22** arbitration requests. In total, we held **52** hearings.

# AIR/CRE FORMS UPDATE -

The Arizona REALTORS® recently negotiated a new agreement with the AIR Commercial Real Estate Association. Under the new agreement, AAR members may download the AIR CRE software for free and additionally receive 50 free credits which are used to purchase AIR commercial real estate forms. Each contact has a certain number of credits associated with it ranging from 1-6 credits depending on the complexity of the contract. All lease and purchase agreements are 6 credit contracts. The software includes 50+ of the most commonly used commercial real estate contracts. The new agreement went into effect September 23, 2022.
